### Requirements for Voting Eligibility:

- 1 You must be a US Citizen and Ohio Resident for at least 30 days before an election;
- 2 You need to be 18 years old on the election day, on general election or primary;
- 3 You must register to vote at least 30 days before the election or earlier;

**In case** → You registered and then moved and/or changed your name, you need to update your voter registration (name and/or address) to vote;

**Then** → If you have not updated your voter registration you may vote using a **provisional ballot** in your precinct. After your registration is verified, the vote will be counted.

4 All voters must bring **acceptable identification to the polls** to verify their identity such as:

- ★ Unexpired Ohio Drivers License
- ★ State Identification Card with present or former address, as long the voter's present residential address is printed in the official list of registered voters of the precinct.

**Or** → Other Accepted Kinds of Identification:

- ★ Military Identification
- ★ Unexpired US government Photo ID showing your name and current address

**Or** → Current Bills (last 12 months) including:

- ★ Utility Bill
- ★ Cell Phone Bill
- ★ Bank Statement
- ★ Government Check
- ★ Paycheck

**Or** → Other Accepted Government Documents:

- ★ College/University document showing your name and current address

5 A voter without the IDs listed above may still vote using a **provisional ballot** or vote early in person or absentee.
